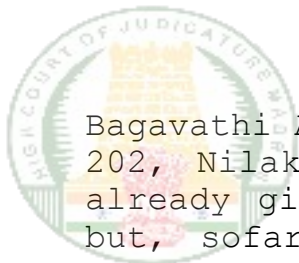

This writ petition has been filed to direct the respondent to grant permission to perform the programmes such as Adal Padal festival on 11.04.2018 at night 07.00pm to 11.00pm at Arulmigu Selva Bagavathi Amman Thirukovil situated at Bethaniapuram, Batlagundu-624 202, Nilakkottai Taluk, Dindigul District and to provide adequate police protection based on the petitioner's representation dated 23.03.2018.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate appearing for the respondent.

3.The learned counsel appearing for the petitioner has submitted that the villagers are conducting the programme (ie.,) 'Adal Padal' 11.04.2018 at 07.00pm to 11.00pm., at Arulmigu Selva



Bagavathi Amman Thirukovil situated at Bethaniapuram, Batlagundu-624 202, Nilakkottai Taluk, Dindigul District and for that, they have already given a representation dated 23.03.2018 to the respondent, but, sofar, no order has been passed. Hence, he has filed the present writ petition.

4.The learned Government Advocate appearing for the respondent has submitted that there is a law and order problem and hence the petitioner's representation is kept pending.

5.Considering the aforesaid submissions, the respondent is directed to consider the representation submitted by the petitioner, dated 23.03.2018 and dispose of the same at early. At the time of passing order, the respondents have to keep in mind the decision of the Hon'ble Supreme Court of India in the case of **Church of God (Full Gospel) in India Vs. K.K.R, Majestic Colony Welfare Association and others**, reported in 2001 - 1 - L.W. (Crl.) 233.

6.With the aforesaid observations, this writ petition is disposed of. No costs.
