PRAYER: Writ petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, calling for the records connected with the impugned order of suspension passed by the second respondent in Parvai: LD4TN/1784 dated 23.12.2017 and the consequential order in Parvai:LD4TN/1784 dated 01.01.2018 which was served on the petitioner on 03.01.2018 and quash the same and consequently direct the respondents to permit the petitioner to join duty with monetary and other service benefits from the date of suspension by order dated 23.12.2017.
