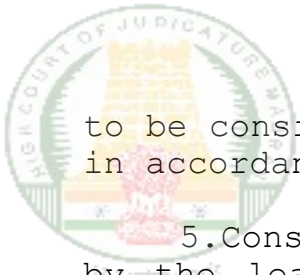
O R D E R

3.With the consent of both sides, the main writ petition itself is taken up for final disposal.

4.The learned counsel appearing for the petitioner submits that if the representation of the petitioner dated 01.02.2018 is directed
