ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.S.GOKULRAJ Advocate for the petitioner, and Public Prosecutor for the respondent, the court made the following order:-

The learned counsel for the petitioner submitted that this Court by an order dated 12.12.2017 directed the petitioner to pay a cost of Rs.10,000/- (Rupees Ten Thousand only) to the credit of the Hon'ble Chief Justice Relief Fund, Madurai Bench of Madras High Court, Madurai within a period of three weeks from the date of receipt of a copy of that order. He further submitted that the petitioner has received a copy of the order only on 02.01.2018 and hence, time has not been expired to comply with the above said condition.



2. Recording the submission of the learned counsel for the petitioner the matter is adjourned to 24.01.2018 for reporting compliance.
