Saravanan produced Transfer Certificate to show that he has undergone Civil Engineering Course and that his date of birth is 24.03.1996. Thus, he is 22 years of age, while the detenu is 21. Both are majors and of marriageable age, have decided to reside together at Sekkumedu, Velayutha Palayam, Karur District.

3. Recording the above, this Habeas Corpus Petition stands closed.
