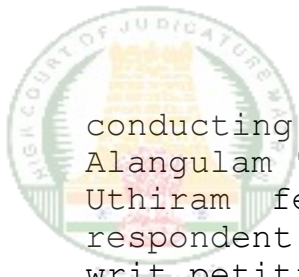

This writ petition has been filed seeking direction to the second respondent to grant permission for conducting various sports activities like (Kabadi Tournament on 07.04.2018 at about 11.00 pm to 08.04.2018 at about 11.00 am at Pillayarkovil Tidal Kalliothu, Alangulam Taluk, Tirunelveli District for the completion of Panguni Uthiram festival at Pillayarkovil Tidal Kalliothu, Alangulam Taluk, Tirunelveli District based on petitioner's representation dated 26.03.2018 within a time frame as fixed by this Court.

2.Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.

3.According to the petitioner, he made a representation dated 26.03.2018 to the respondents to grant permission and protection for



conducting Kabadi Tournament at Pillayarkovil Tidal, Kalliothu, Alangulam Taluk, Tirunelveli District for the completion of Panguni Uthiram festival. As no order has been passed by the second respondent in the said representation, the petitioner has filed this writ petition with the aforesaid prayer.
