Prayer in CMP(MD). 3449/ 2018 :

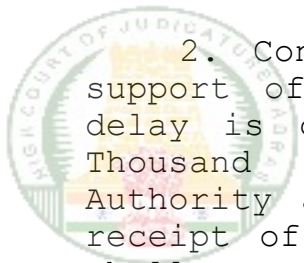
To Condone the delay of 151 days in representing this CMSA (MD)SR.No.34607 of 2017 and thus render justice.
