This petition is filed to extend the time limit for executing sureties granted in Crl.O.P(MD)No.747 of 2018, dated 17.01.2018.

2.This Court, by order dated 17.01.2018 made in Crl.O.P(MD) No. 747 of 2018, granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was



made ready. However, the petitioner did not comply with conditions, within the time prescribed by this Court. Hence, he has approached this Court with the present petition for extension of time.

3.The learned counsel appearing for the petitioner submitted that due to his thigh fracture, the petitioner has taken treatment and therefore, he could not produce the sureties within the time prescribed by this Court and hence, he prays for extension of time.

4.Heard the learned Government Advocate (Crl. side).

5.Considering the reasons stated in the petition, this petition is ordered and the time to comply with the order is extended till 24.04.2018.
