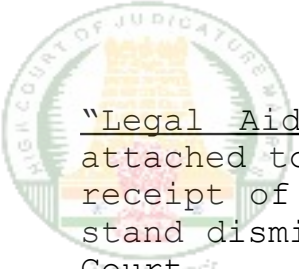
PRAYER IN CMA(MD) No.SR338 of 2017:
