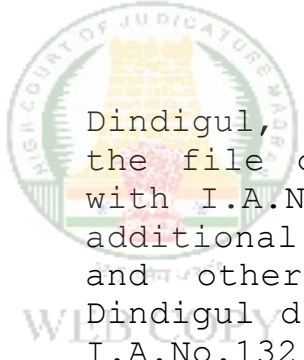

ORDER

In both cases, after considering the facts and other circumstances, the learned Additional Sub Judge, Dindigul dismissed the appeal in A.S.No.70 of 2011 as well as the I.A.No.132 of 2013 in A.S.No.17 of 2011.
