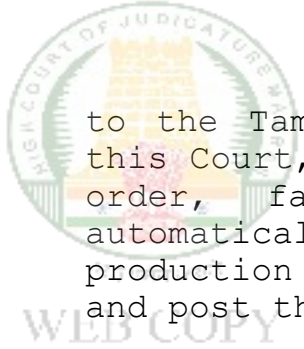
PRAYER IN CMA(MD) No.SR34876 of 2016:-
