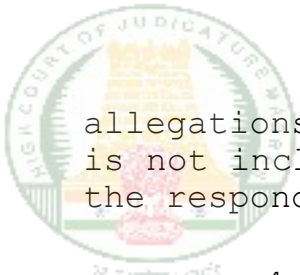

2.The ground on which this petition is being moved is that the respondents have not complied with the conditions imposed on them.

3.The submissions made by the learned Counsel for the petitioner is undoubtedly correct. However, taking note of the



allegations made against the respondents 2 to 4 herein, this Court is not inclined to cancel the Anticipatory Bail granted in favour of the respondents 2 to 4.

4. This Criminal Original Petition stands dismissed, accordingly.
