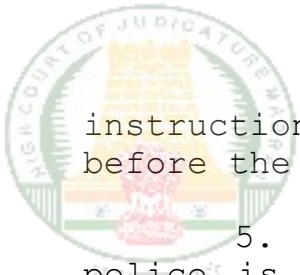
This petition has been filed to direct the 2nd respondent to register a case based on the petitioner's complaint, dated 27.03.2018 and file a report before the concerned Court.
