PRAYER IN CRL MP (MD) No. 459 of 2018:

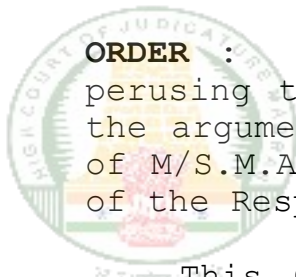
