ORDER

3.It is needless to point out that whenever any representation / application is made to the statutory authorities, the respondents are bound to dispose of the same in one way or other, rather than keeping it pending indefinitely.

4. In view of the limited prayer sought for and without going into the merits of the petitioner's representation dated 21.03.2018, there shall be a direction to the second respondent to



consider the petitioner's representation on its own merits and pass appropriate orders within a period of eight weeks from the date of receipt of a copy of this Order. Such an exercise shall be done after giving due opportunity to the petitioner and to any other person who may be interested in the subject matter.

5. With the above observation, this writ petition stands allowed. No costs.
