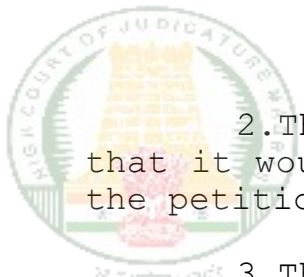

ORDER

4.In view of the submission made by the parties concerned, without expressing any opinion, this Court is inclined to direct the 4th respondent to consider the petitioner's representation dated 23.03.2018 and pass suitable orders on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order. The petitioner is also directed to send a copy of this order along with his representation to the 4th respondent.

5.With the above direction, this Writ Petition is disposed of. No costs.
