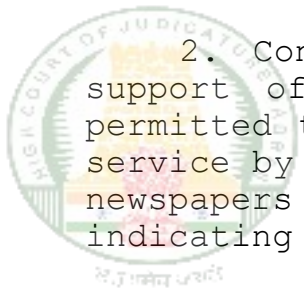

Prayer in CMA(MD). 841/ 2012 :

To set aside the fair and decreetal order dated 14.09.2011 made in M.C.O.P.No. 552/2006 on the file of Motor Accident Claims Tribunal, (III Additional Sub Judge), Madurai and allow this appeal and thus render justice.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.S.SRINIVASA RAGHAVAN, Advocate for the petitioner the court made the following order:-
