The learned counsel appearing for the petitioner submitted that the petitioner made a representation to the second respondent to conduct a public meeting. But, the said representation was rejected by the second respondent and another representation was made by the petitioner to the first respondent on 09.04.2018 to convene a public meeting on 13.04.2018. The date sought for by the petitioner is now lapsed and therefore, the learned counsel appearing for the petitioner seeks liberty to make a fresh



representation to the first respondent seeking permission in the alternative place.

2. In view of the above, no further adjudication is necessary in the present writ petition. Hence, this Writ Petition is dismissed. However, liberty is granted to the petitioner to approach the Deputy Superintendent of Police, Alagulam, Tirunelveli District, to make a fresh representation, if he is so advised. No costs.
