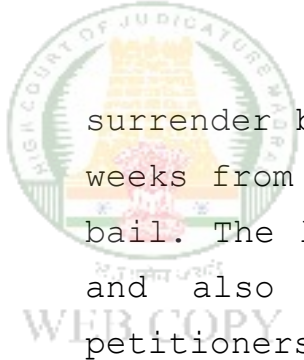

ORDER : The Court Made the following order :-

The petitioners apprehending arrest at the hands of the respondent police for the offences punishable under Sections 294(b), 323, of IPC and Section 3 (1) (r), 3(1)(s) and 3(2) (Va) of SC/ST (Prevention of Atrocities) Amendment Act 2015, in Crime No.11 of 2018, seek anticipatory bail.

2.The petitioners earlier moved this Court and this Court issued a direction, but then, they were not able surrender before the court concerned.
