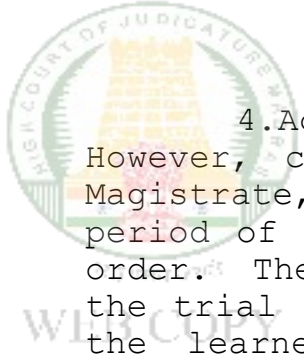

2. The learned counsel appearing for the petitioner would submit that in this case trial has been commenced and P.Ws.1 to 13 have been examined.
