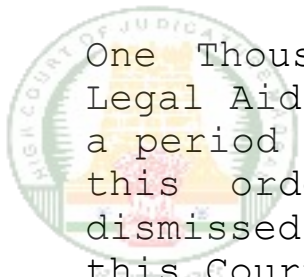
PRAYER IN CMA (MD) No.SR40048 of 2016 :
