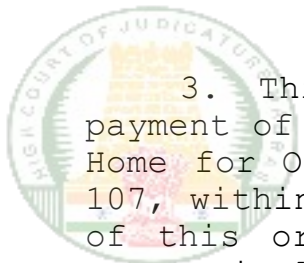
PRAYER IN CMA(MD) No.SR3042 of 2018:
