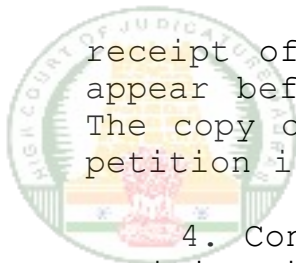
ORDER:
