2.The Special Court for Land Grabbing, Ramanathapuram is directed to transfer the entire case records in Crime No.1 of 2013 to the file of the learned Judicial Magistrate, Paramakudi, within a period of one [1] month from the date of receipt of a copy of this order.

3.The petitioner is given liberty to file a protest petition before the learned Judicial Magistrate, Paramakudi, after the case records reaches the concerned Court. The petitioner is at liberty to raise all the grounds and prosecute the case in accordance with law.



4.The Criminal Original Petition is disposed of, with the above direction.
