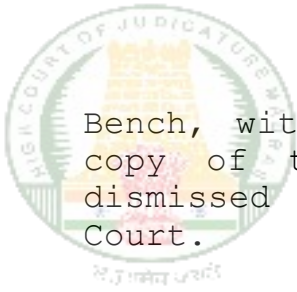

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S. M.PRAKASH, Advocate for the petitioner, the court made the following order:-
