This petition has been filed to modify the condition imposed on the petitioner in Crl.M.P. No.305 of 2018, dated 28.03.2018.

2. The earlier condition imposed by the Learned Additional Chief Judicial Maistrate, Kumbakonam, to appear before the respondent police, Trichy, every Monday is modified and the petitioners are directed to appear once in a month before the Special Camp Office, at Trichy.

3.Both the petitioners undertake that they will stay within the city limit of Mumbai and shall not travel outside the Mumbai city limit and they will travel to Trichy only for the purpose of complying with the condition imposed by the Trial Court. In all



other respect, the earlier condition imposed by the trial Court will stand.
