3.This Writ Petitioner seeks issuance of a Writ of Mandamus, directing respondents 3 and 4 to provide bus transport facilities (bearing route No.127 A, 67 T Enroute Kalakkadu to Tirunelveli) to petitioner's village namely, Keela Sadayamankulam Village, Nanguneri Taluk, Tirunelveli District based on the proceedings of fifth respondent dated 16.03.2017 and by considering his representation dated 04.04.2018.
