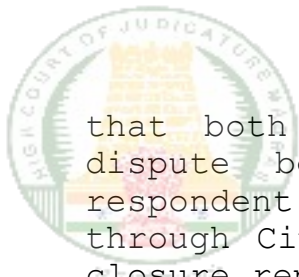
ORDER

that both the parties have appeared for enquiry and since the dispute between the parties is purely civil in nature, the respondent police advised both the parties to work out their remedy through Civil Court and closed the complaint. He also produced the closure report before this Court.
