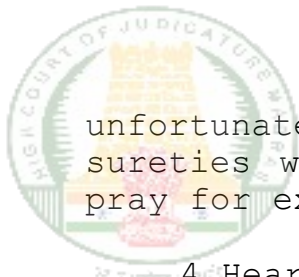
Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.M.KARTHIKEYA VENKITACHALA, Advocate for the petitioner and of MR.A.ROBINSON, Government Advocate (Crl.side) on behalf of the Respondent the court made the following order:-

This petition is filed to extend the time limit of the petitioners' surrender and execute the sureties in Crl.O.P(MD) No.4711 of 2018, dated 26.03.2018.

2.This Court, by order dated 26.03.2018 made in Crl.O.P(MD)No. 4711 of 2018, granted anticipatory bail to the petitioners and directed the petitioners to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time prescribed by this Court. Hence, they have approached this Court with the present petition for extension of time.
