Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to Condone the Delay of 542 days in representing the writ petition, and permit the petitioner to get along with the main petition.

PRAYER IN WP (MD) No.SR44022 of 2016: To issue a "WRIT OF CERTIORARI" or any other appropriate writ, order or direction in the nature of a writ calling for the records on the file of the respondent in TIN:33395361940/2012-13 dated 23.06.2016, and quash the same as illegal, invalid and against the Principles of Natural Justice.

ORDER: This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.A.CHANDRASEKARAN, Advocate for the petitioner the Respondents the court made the following order:-

This petition is filed to condone the delay of 542 days in representing the Writ Petition.

Being satisfied with the reasons stated in the affidavit filed in support of the petition, this petition is allowed and the delay of 542 days is condoned on condition that the petitioner shall deposit a sum of Rs.500/- (Rupees Five Hundred only) before the Tamil Nadu Mediation and Conciliation Centre, attached to the Madurai Bench of Madras High Court, Madurai, within a period of one week from the date of receipt of a copy of this order, failing which, this petition shall stand dismissed automatically without any further reference to this Court.

4. The amount deposited can be used for the purpose of infrastructure facilities for the Tamil Nadu Mediation and Conciliation Centre.
