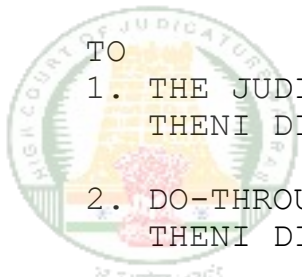
2.Heard the learned counsel for the petitioner and the learned Government Advocate(Crl.Side) for the respondent.
