Prayer in WP(MD)NO.9488/2016 :

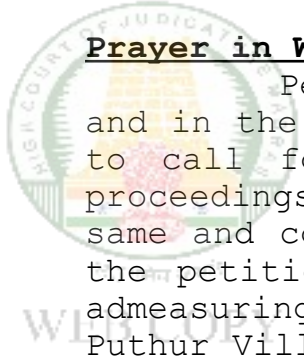

Prayer in WP(MD).9517/2016 :

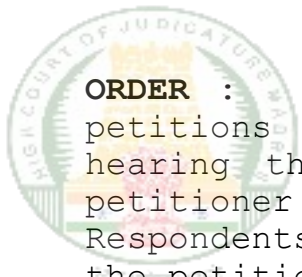
