The complaint was enquired and the first petitioner appeared for enquiry and gave an undertaking he will seek his remedy before the appropriate forum. Pursuant to the undertaking made by the petitioners, the complaint was closed.



4. In view of the above, the present petition filed by the petitioners cannot be sustained and the allegations of the petitioners against the respondent police are not correct.

5. In view of the aforesaid submissions made by the learned Additional Public Prosecutor, this Criminal Original Petition is dismissed.
