Pursuant to the order of this Court, the Election Officer, the Hon'ble Dr.Justice T.Mathivanan (Retd.) and the Assistant Election Officer Mr.R.Karunanidhi were conducted election in the peaceful manner and the same was completed on 16.08.2018. 3.The Church / North Tamil Conference of Seventh day Adventists, Thiruchirappalli is directed to pay an additional remuneration for a sum of Rs.5,00,000/- to the Election Officer the Hon'ble Dr.Justice T.Mathivanan (Retd.) and a sum of Rs.2,00,000/- to the Assistant Election Officer Mr.R.Karunanidhi on or before 24.10.2018 and report before this Court on 25.10.2018 at 3.30 p.m. through video conferencing.

4.The Church / North Tamil Conference of Seventh day Adventists, Thiruchirappalli is directed to submit a report for the payment of additional remuneration to the Election Officer and the Assistant Election Officer. Post the matter on 25.10.2018 at 03.30 p.m. through Video Conferencing.
