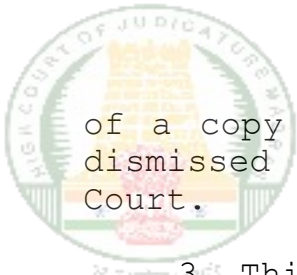
PRAYER IN CMA(MD) No.SR43086 of 2016:-
