O R D E R

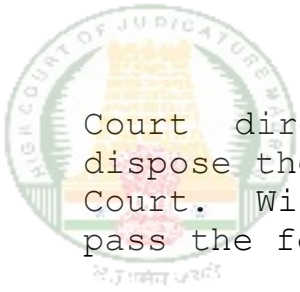

2. The revision petitioner is the plaintiff and the revision respondent is the defendant in O.S.No.165 of 2014 before the learned District Munsif, Thirumangalam. The petitioner/plaintiff has filed O.S.No.165 of 2014 seeking permanent injunction against the respondent/defendant and the same is pending without passing any orders before the trial Court.
