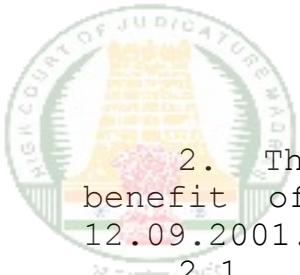

2.1. There is an undertaking on behalf of the learned Additional Advocate General that the representation of the petitioner would be considered and appropriate orders be passed.

3. Under such circumstances, we direct the first respondent to consider the representation of the detenu's father and to pass suitable orders thereon on merits and in accordance with law, within a period of three months from the date of receipt of a copy of this order.
