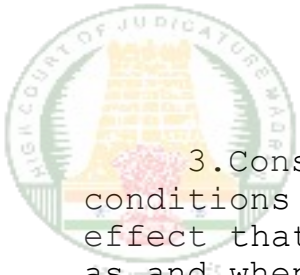
Prayer in CRL OP(MD). 2331/ 2018 :
