Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorari calling for the records relating to the impugned order passed by the 1st respondent in his proceedings C.No. A2/6259/143/2015 R.O.No. 190/2015 dated 27.05.2015 and the consequential impugned order passed by the 2nd respondent in his proceedings C.No.F1/24356/2015 D.O.No. 784/2015 dated 03.06.2015 and quash the same as illegal.
