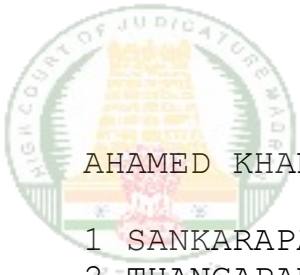

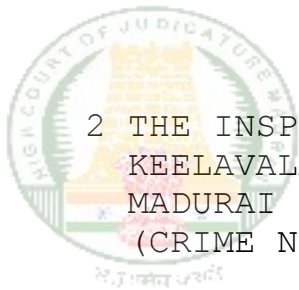

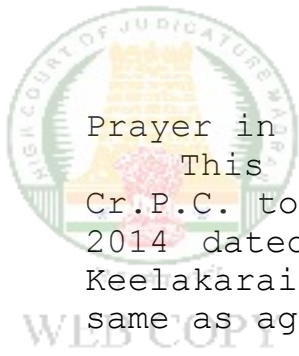

3. In view of the same nothing survives in these petitions and the same are dismissed. Consequently connected miscellaneous petitions are closed.

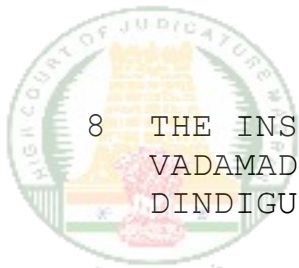
