2. In view of the above, the Writ Petition is dismissed as withdrawn. No costs.

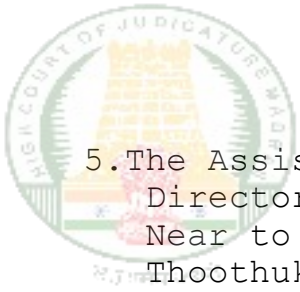
