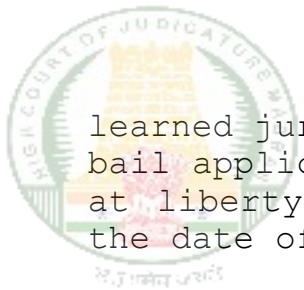
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner is shown as Accused No.2 in Crime No.1 of 2012. The petitioner apprehends arrest at the hands of the respondent police for the offences punishable under Sections 7(1)(A) and 5(1)(d)(ii) of Prevention of Immoral Traffic Act, subsequently, altered into Sections 7(1)(A) and 5(1)(d)(ii) of Prevention of Immoral Traffic Act, Sections 366-A, 372, 373, 376 and 506(ii) IPC r/w Section 3(i)(xii)3(2)(v) of SC/ ST(POA) Act, 1989 and Section 4 of Protection of Children from Sexual offences Act, 2012.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondents.

3. The petitioner is directed to surrender before the learned II Additional District and Session Judge (Special Court for PCR Cases), Tirunelveli, within a period of two weeks from the date of receipt of a copy of this order and apply for regular bail. The



learned jurisdictional Special Court shall consider the petitioner's bail application and pass orders on the same day. The petitioner is at liberty to issue notice to the defacto complainant well before the date of surrender.

4. Accordingly, this Criminal Original Petition is disposed of.
