3. It is noticed that this writ petition is a second round litigation. The petitioner though has obtained an order in the previous writ petition with a direction to consider the petitioner's representation, the petitioner could not get any relief from the respondents.

4. Having regard to the nature of grievance expressed by the petitioner, without expressing any opinion on the merits of the petitioner's case, this Court is inclined to pass the following direction:-

"the respondents 1 and 2 are directed to consider and dispose of the petitioner's applications dated 31.12.2013, 18.05.2015 and 03.11.2015 to upgrade the petitioner's school, on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order."

5. Accordingly, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
