This Criminal Original Petition has been filed seeking a direction to the learned Principal District Munsif-cum-Judicial Magistrate at Eraniel, to dispose of C.C.No.314 of 2008.

According to the learned counsel appearing for the petitioner, the case has been registered in the year 2006 and the same was taken on file in C.C.No.314 of 2008 by the learned Principal District Munsif-cum-Judicial Magistrate, Eraniel. Further, three witnesses were examined on the side of the prosecution and thereafter, no one was examined and the case was adjourned from time to time. Hence, the petitioner has approached this Court with the present Criminal Original Petition for the relief stated supra.

3. The learned Government Advocate (Criminal side) submitted that already three witnesses were examined on the side of the prosecution and the case is posted for further evidence.
