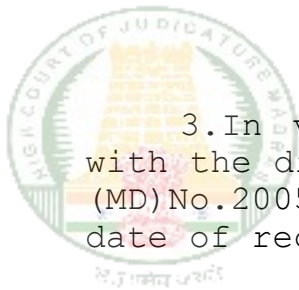

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of MR.PORKODI KARNAN, Advocate for M/S.POLAX LEGAL SOLUTIONS for the petitioner and of MR.K.SUYAMBULINGA BHARATHI, Government Advocate (Crl.Side) on behalf of the Respondent, the court made the following order:-

This petition has been filed to extend the time limit of the petitioner to execute sureties before the concerned Magistrate Court.

2.The learned counsel for the petitioner seeks time to produce sureties as per the order of this court dated 02.11.2018. The petitioner ought to have executed sureties with in a period of 15 days from the date of receipt of copy of this order. The learned counsel would submit that due to recent natural calamity, namely "Gaja Cyclone", the petitioner was unable to execute the sureties and that now sureties are available and he is ready to comply with the conditions.
