These petitions are ordered on payment of separate Court fee.

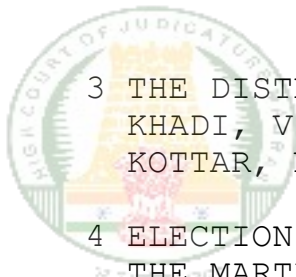
