3. Considering the facts and circumstances of the case and upon hearing the learned counsel appearing for both sides, this Court is of the view that the petitioner could be granted the relief as prayed for with certain conditions.

4. Accordingly, the petitioner are ordered to be enlarged on bail on executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate,



Tenkasi and on further condition that the petitioners should report before the said Magistrate, on the first working day of every English calender month at 10.30 a.m., until further orders.
