ORDER : The Court Made the following order :-

The petitioners, who are arrayed as A1 and A2 apprehending arrest at the hands of the respondent police for the offences punishable under Sections 379 IPC (Sand) r/w. 4(1), 4(2), 21(2), 21(5), MMRD Act, 1957 in Crime No. 271 of 2018, on the file of the respondent Police seeks anticipatory bail.
