J U D G M E N T**[Judgment of the Court by K.RAVICHANDRABAABU, J.]**

This writ appeal is directed against the order passed in W.P. (MD) No.8420 of 2014, dated 21.05.2014.

2. The fifth respondent in the writ petition is the appellant herein. Though this writ appeal is filed by raising very many grounds, we are not inclined to go into all those contentions in view of the fact that the very prayer sought for in the writ petition is in respect of a festival scheduled to be conducted between 01.06.2014 and 05.06.2014 and on 11.06.2014 at the subject matter temple and thus, the said prayer has become infructuous.

3. Accordingly, this writ appeal is dismissed as infructuous, without expressing any view on the merits and contentions raised by both parties. No costs. Consequently, connected miscellaneous petitions are closed.
