PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

Heard both sides.

2.The petitioner, who was arrested on 03.05.2018 for the alleged offences punishable under Sections 341, 294(b), 387, 307 and 506(ii) IPC, in Crime No.56 of 2018 on the file of the respondent police, seeks bail.

3.The case of the prosecution is that the petitioner obstructed the defacto complainant for extracting money from the defacto complainant and also threatened him by using filthy language.

4.The learned Additional Public Prosecutor submitted that there are two previous cases pending against the petitioner. Therefore, he opposed to grant bail to the petitioner.

5.Considering the facts and circumstances of the case and also taking note of the period of incarceration of the petitioner, I am of the view that the petitioner could be enlarged on bail. Accordingly, it is ordered that the petitioner shall be released on bail, on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a likesum to the satisfaction of the learned Judicial



Magistrate No.I, Tuticorin and on further condition that the petitioner shall report before the respondent police daily at 10.30 a.m. for a period of two weeks and thereafter, as and when required for interrogation.
